

NABIP - Texas Instructor Certification

The Texas Department of Insurance Continuing Education Program rules require providers to certify that course instructors will be **experienced and qualified** in the subject taught. Furthermore, providers and instructors must certify that they will comply with all provider and course requirements as outlined in the program rules and NABIP – Texas’ professional development policy and procedure. **All instructors must coordinate with the local chapter professional development chair (for chapter sponsored courses) or the NABIP - Texas Executive Director (for non-chapter sponsored courses) prior to scheduling a course presentation.** This certification, or a document similar to this certification, must be maintained by the providers for four years and be available to the Department upon request.

NABIP - TX DOs And DONTs

DO....

1. Familiarize yourself with and follow the rules regarding courses on the TDI website regarding teaching CE courses.
2. Check to make sure that the CE you want to use is still certified and that certification has not expired.
3. Speak generally about what companies in the market are doing, etc. but do not use specific company names.
4. Ask CE attendees to defer marketing related questions until after the CE has ended.
5. Speak as a CE instructor and not as a representative of a specific company.
6. Make sure that attendees don't leave the room for long periods of time. Ask attendees to turn off cell phones, pagers, etc.
7. Give attendees opportunities to ask questions and to participate in the presentation.

DON'T....

1. Don't include your company logo on the CE handouts or materials.
2. Don't include marketing materials with the CE handouts and materials.
3. Don't spend CE time advertising your particular product. This can endanger your CE class.
