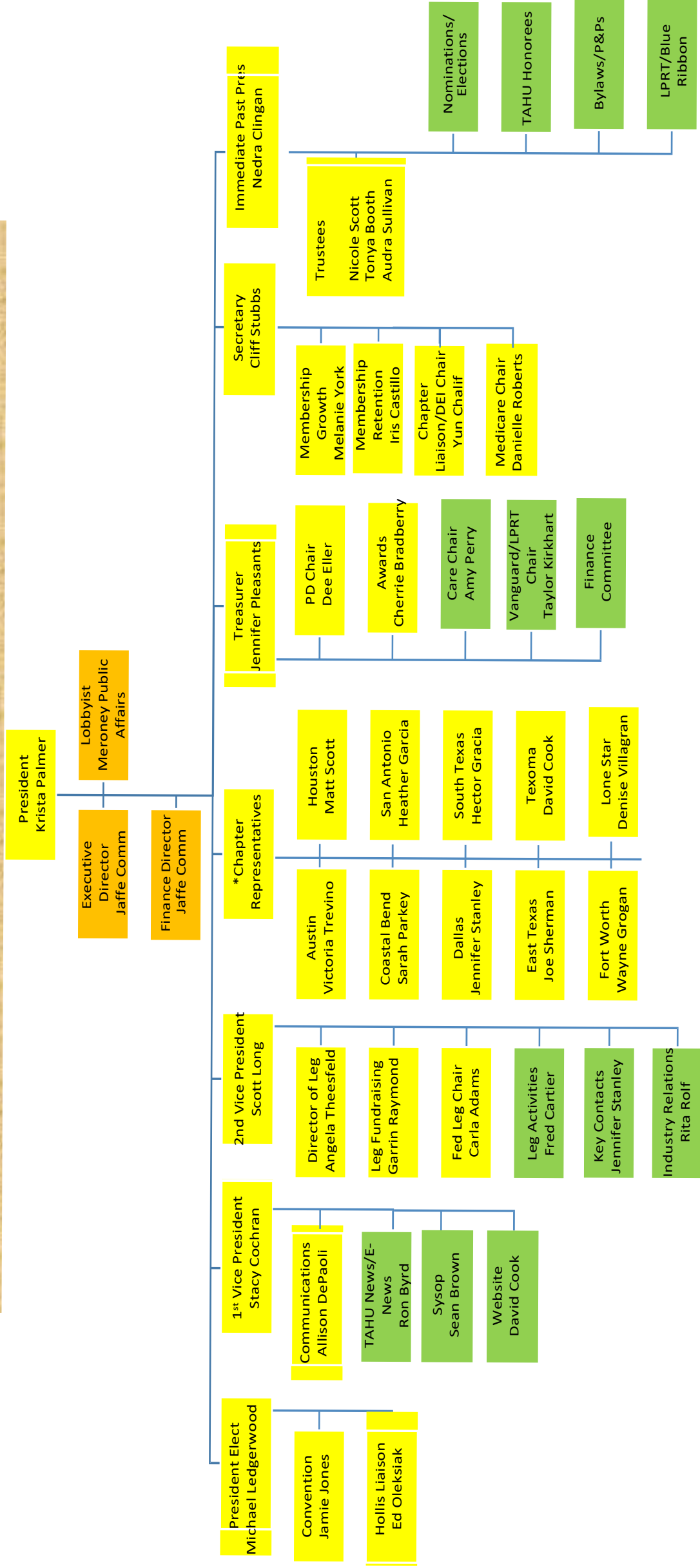


CHAPTER RULES
